**ATLAS SUBSIDIARY COMPLETES 40<sup>TH</sup>  
SHIPMENT of COPPER CONCENTRATE**

Atlas Consolidated Mining and Development Corporation (Atlas) is pleased to report the completion on 13 April 2011 of its 40<sup>th</sup> shipment of copper concentrate since the start of mining operations through its subsidiary Carmen Copper Corporation (CCC).

Revenue from this shipment is estimated to reach US\$12.01 million (inclusive of gold credits) based on a total weight of approximately 4,717.63 dry metric tons (dmt) of copper concentrate containing 27.80% copper, 2.42 grams of gold per dmt and 22.82 grams of silver per dmt according to preliminary assay analysis.

The shipment which was loaded on board the vessel M/V Dong An at the Sangi Port in Toledo City, Cebu is consigned to Yanggu Xiangguan Copper Co. Ltd of Shandong, People's Republic of China.

The next shipment is expected to be made on or about 25 April 2011.
